Rose and Turtle River Estates Ltd. has been signed for the sub-division and purchase of the Westerly 186 Feet of all that portion of the N 1/2 of Section 9-24-15WPM taken for the Right-Of-Way and Station Grounds of the Canadian National Railway Plan 408 DLTO and subject to the Easement of approximately 66 feet for a Public Road;

AND WHEREAS the said Memorandum of Agreement to complete the said subdivision and obtain the Certificate of Title to the land as a whole, has not been completed by June 1st, 2020, due to the requirement of an Encroachment Agreement;

AND WHEREAS both parties are in agreement to an extension of the original Memorandum of Agreement;

THEREFORE BE IT RESOLVED that the date for the completion of subdivision and purchase of land as described in the original Memorandum of Agreement between the Municipality of Ste. Rose and Turtle River Estates Ltd., dated April 26, 2017, be extended to June 1st, 2022.
